

For the avoidance of doubt, use of the term VICEROY in a pay-per-click marketing scheme shall be construed broadly, and shall include any advertisement targeted based on content featuring the term VICEROY, its phonetic equivalents, any mark confusingly similar thereto, or any of the Resort's (or its affiliates' or parent entity's) registered or common law trademarks, or content regarding the Resort or any of its affiliates' or parent entity's properties, including but not limited to the use of landing pages regarding the Resort or any of its affiliates' or parent entity's properties to target advertisements in Google Dynamic Search Ads.

Cancellation/No Show Policy

- Reservations may be cancelled 14 days prior to arrival with no penalty. Reservations cancelled within
 days of arrival, will result in forfeiture of two nights room and tax. (Not applicable for Festive Season
- Early Departures and No-Shows will be charged a 100% penalty
- All penalty charges are net, non-commissionable. Payments are to be made directly to the Resort's bank account.

Payment Terms & Conditions - PREPAYMENT

All monies received by the Distributor from persons purchasing holidays at the Resort are monies held in trust by the Distributor for the Resort. All monies are to be received in the Resort bank account 21 days prior to guest arrival. The Resort reserves the right to cancel any booking which is not paid 21 days prior. Payment must be made in full at the time of booking for all reservations made within 21 days of arrival. Should the client arrive without such payment, the Resort reserves the right to charge the client with the full amount on arrival. Remittance advice to be sent to the Resort stating details of bank account credited and invoices paid. Failure to comply with these payment conditions will result in possible cancellation of arriving rooms.

Payment Terms & Conditions - FESTIVE 2019

- 50% deposit charged at time of booking and remaining balance charged 90 days prior to arrival for st between December 20, 2019 – January 4, 2020
- Cancellation 90 days prior to arrival For stays between December 20, 2019 January 4, 2020
- Full or partial cancellations within the 90 days for the dates of December 20, 2019 and January 9, 202 dates will result in forfeiture of full prepayment of room, tax and service or the nights cancelled if a partial cancellation. Once a reservation is cancelled the accommodation(s) will be released back to the recent
- Early Departures and No-Shows will be charged a 100% penalty.
- All penalty charges are net, non-commissionable. Payments are to be made directly to the
- Resort's bank account.
- FESTIVE SEASON MINIMUM STAY REQUIREMENT: All room categories require a 5-night minimum len of stay for arrivals from 22 December to 31 December 2019.
- Deductions are NOT allowed without prior written approval of the resort
