A la carte restaurants have flexible opening hours. <u>The Restaurant Senzu Kazan is not included in the Half Board and there is no credit for Hotel clients and payable at the Restaurant( no possibility to charge the Dinner to the client's room). - 7) The Travel Agency/Tour Operator shall not sell to the public, via their own or third parties website, at a price inferior to that resulting from an increase of a minimum 25% on the rates agreed in this document. Should the Travel Agency/Tour Operator not comply with this condition, the Hotel will have the right to terminate this present contract.

- 1. **Release Periods:** The "Hotel" agrees to maintain the availability of the number of rooms allocated to the "Travel Agency/Tour Operator" in accordance with the timings stipulated in Clause "A" of this contract and said timings are understood to be prior to each arrival date, having previously been confirmed by the Rooming List. Once this time limit has elapsed, the "Hotel" may dispose of any unused rooms, which have not been confirmed by the "Travel Agency/Tour Operator"
- 2. Invoicing and Payments: The "Hotel" will forward to the "Travel Agency/Tour Operator" all invoices pertaining to each and every one of their clients or group of clients and will attach to the same the original voucher or the corresponding Rooming List. The "Travel Agency/Tour Operator" agrees to pay the amount(s) stipulated on the previous clauses and invoice(s) for their client(s) within the time limit agreed in the section B of this present contract. A breach of payment conditions on behalf of the "Travel Agency/Tour Operator" will give the "Hotel" the right to cancel or suspend the contract providing payment is requested from the "Travel Agency/Tour Operator" and the amount outstanding is still not paid within a maximum of five (5) days from the date of request. This action will not affect the "Hotel" rights to exercise the corresponding legal action for the breach of contract.
- 3. Clients Claims: In accordance with the Spanish Law 21/1995, dated July 6th relating to package holidays, it is absolutely essential that the claims should be presented in writing, to the Hotel Manager during the client's stay. Any possible retention or deduction, for whatever reason effected unilaterally by the "Travel Agency/Tour Operator", to any payment without the previous authorization in writing by the hotel will not be valid and will be considered as a breach in the payment obligations on behalf of the "Travel Agency/Tour Operator" and will give the "Hotel" the right to automatically cancel the contract. No retention or deduction will be allowed providing that the claim had not been presented in writing to the hotel within the period of one year from the client's stay in the hotel.
- 4. **No Shows and Cancellations:** If after confirming a reservation the client should not arrive, the "Hotel" reserves the right to debit the "Travel Agency/Tour Operator" who agrees to pay the No-Show charge indicated in the Section 4 of this contract. Any cancellation should be advised in accordance with the time limits stipulated in the Section 4 of this contract and should this not be fulfilled the "hotel" reserves the right to debit the "Travel Agency/Tour Operator" and the "Travel Agency/Tour Operator" agrees to pay the same charge indicated for No-Shows indicated in the Section 4 of this contract
- 5. **Presentation of the hotel services:** The "Hotel" will provide to clients of the "Travel Agency/Tour operator" the services in line with its category. At the same time, the "Hotel" guarantees that should it be, due to its own fault, unable to accommodate a client with a corresponding reservation, it will provide alternative accommodation in another hotel of the same or superior category until such time as the "Hotel" has availability in the originally contracted establishment, when the guest(s) must be reinstated. Should the guest decide not to return to the originally contracted establishment, the difference in price between both establishments will be paid either directly by the guest or by the "Travel Agency/Tour Operator". Should a client be accommodated in an alternative hotel proposed by the "Travel Agency/Tour Operator", in the event of a difference in price, this should be absorbed by the "Hotel" providing this has been previously agreed and accepted.
- 6. **Non-Liability**: The "Hotel" does not accept liability for deficiencies, inconveniences or damages in relation to the accommodation, food and beverage and other hotel services which may originate as a consequence of any kind of alteration in the normal working activity within the hotel such as strikes, closure by proprietors, etc. The "Hotel" is also exempted from liability for all damages that could be suffered by clients, their person or their belongings, due to acts of terrorism, robberies or any criminal behaviour, which may occur within the hotel premises.
- 7. **Sales information**: The "Travel Agency/Tour Operator" will inform the hotel, in writing, at least every month about the sales situation and will provide further information in relation to the evaluation of the sales when requested.
- 8. **Force Majeure**: The agreement reached in this document will be deemed without any effect, whatsoever in case of "force majeure", such as wars, catastrophes, epidemics, strikes and similar
- 9. **Confidentiality of the contract:** The clauses and conditions of this present document are confidential; therefore the "Travel Agency/Tour Operator" is obliged to keep them as such. At the same time the "Travel Agency/Tour Operator" agrees that they will not establish public price comparison of the contracted hotel with other agencies or Tour Operators who may have an allotment reserved in the same hotel
- 10. **Modification of the contract and communications:** Any possible modifications related to this present contract must always be made in writing and by mutual agreement on the understanding that the rest of the contract will remain in force
- 11. **Duplication of contracts**: In case of discordance between the agreements stipulated in this contract and those agreed in any other contract previously signed by the parties, it is understood that those of this present contract will prevail
- 12. **Advertising and presentation in brochures**: The "Travel Agency/Tour Operator" agrees to feature the Hotel object of this contract, in its main brochure with photographic material, written description and the corresponding logo. A copy of the brochure should be in hands of the "Hotel" at least 15 days before the start of the season and all the contracted beds/rooms should be put up for sale
- 13. **Jurisdiction and arbitration:** For any questions that may arise from the interpretation or execution of this agreement, the Parties will renounce their rights and submit themselves to the Jurisdiction of the Low Courts and Tribunals of Santa Cruz de Tenerife
- 14. Applicable Law: The present contract is governed by and construed in accordance with Spanish law. Each party submits to the jurisdiction of Spanish Courts.

**Additional Clause:** The Travel Agency/ Tour Operator acts in this Agreement in name and on behalf of its representative, with join and several responsibility and assumes expressly and voluntarily all the rights and obligations derived from this Agreement, according to articles 1140 and following of the Spanish Civil Code
