Due to changes with the hotel's transportation providers, effective immediately, some of the shuttle transportation service will change. Although shuttles to SeaWorld, Aquatica, and Universal Studios will continue to be complimentary and included in the Resort Fee, scheduled transportation to Walt Disney World will now be \$8.00 per passenger round-trip. Children 2 years old and under will continue to ride for free.

ALL shuttles still require one-day advance reservations which can be made at the Expedia Local Expert Desk located in the main lobby. They must be made in person so that guests can receive a voucher for their scheduled hotel departure, which must be presented to the shuttle driver upon boarding. Vouchers for transportation to Walt Disney World may be purchased at the Expedia Local Expert Desk and will only be sold as a round-trip voucher. Great changes continue at the Doubletree behind the green screen wall along International Drive and the corner of Westwood Boulevard. The wall of screen is to protect any items from travelling out of the construction area and it covers all the exciting work taking place behind the wall.

Our new outdoor courtyard pavilion is under construction and the roof is going up this week. The large grand palm trees that flank each side of the Terrace in the Palm Promenade are planted. The new Majestic ballroom concrete foundation pour is complete and the steel walls and roof construction are set to start the week of March 27th. The new and expanded fitness centre looks great and is now projected to open the first week of April on the 5th.

Current renovations to the hotel's existing meeting and event space has started and the tower meeting rooms are almost complete. The Oceans and Great Lakes ballrooms received new carpet and wall treatments. The Lakes Conference Center changes are looking great with an addition of two new boardrooms. All of the existing guest restrooms are being renovated. The Lakes Conference Center and the Tower Conference Center second floor restrooms are now complete. All remaining restrooms near the meeting and event locations will continue to be renovated.

The trees have been removed from the front of the tower building to make way for the new covered walkways. New screen fencing will go into place next week to cover the location of the new covered walkway build. The front entrance patio of the Ocean's Ballroom has been enclosed and the new Oceans ballroom lobby enhancement is under construction.
