Useful Information

Mechanical / customer service difficulties: In the unlikely event of any mechanical failure/difficulties or local customer service issues the renter must notify the rental location immediately. These queries cannot be resolved rapidly by Affordable Car Hire if a complaint has not been reported at the location.

Other information: At the time of collection the renter is required to sign a contract/rental agreement with the local car rental company. Once signed the renter accepts the terms and conditions of the car hire company and no refund claims for any local items signed between the client and supplier will be accepted by the Company. The Company acts as agent for the local car hire company providing the motor vehicle.

Form(s) of ID: A valid photo ID (Passport or National ID)

Driving licence: Drivers must produce a full national driving licence from their country of residence for at least one year. Licences must be written in Roman Script otherwise an International driving licence/permit will be required. All parts of a licence must be given to the car hire company. No refunds will be given for rentals rejected due to non-production of a driving licence or non-disclosed endorsements. Faxed or photocopied licences are not acceptable.

Extensions: Any extension to the pre-agreed rental duration as stated on this voucher is subject to a local charge to the renter unless authorized by Affordable Car Hire in the UK.

The car rental booking is held between Affordable Car Hire (ACH) and the agent who has booked the car for and on the behalf of the consumer. They act as ,an agent for the consumer, ACH hold no responsibility to the consumer should the agent default on payment, ACH have the right to cancel vouchers and charge the consumer directly.

Failure to present a credit card, in the lead drivers name, at the time of collection and to the car rental supplier may prevent the supplier being able to hold the excess deposit on your reservation, in which case the optional Excess Waiver offered by the supplier may become compulsory to ensure you receive your rental vehicle. In this instance we would be unable to claim a refund for any insurances charged.
