RATES:

Rates are net, non-commissionable and subject to state/local taxes, currently at 14% plus a daily Resort Fee of \$18 plus 14% tax per room per night (subject to change). Dates subject to WeekDay (Sun-Thu) and WeekEnd (Fri-Sat) rates patterns as outlined. Rates are based on sgl/dbl occupancy. Additional charge for extra person of \$20 per night. Children, age Eighteen (18) and under, stay free of charge when sharing room with adult in existing bedding. Roll-away bed available at \$25 additional plus tax per night in rooms that allow. Cribs are complimentary and upon request. Maximum occupancy for Traditional Rooms is 2 people and Suites 4 people.

A Resort Fee of \$18.00 per day, per room, plus 14% tax will apply to all bookings (includes: WiFi internet access, local and 1-800 dial up calls, 2 chaise lounge chairs at pool or beach, daily newspaper, access to the fitness center and use of the in-room safe (subject to change.) Resort fee charge is mandatory and may be payable by the tour operator/account or directly by the guest locally. The Hotel is Pet Friendly. Pet policy allows small pets (under 25 lbs.). Dogs & cats only, one-time cleaning fee of \$95 will apply. Guests are responsible for any damages made by pet.
